BL-94 CONSTRUCTION COMPLETE: ROUNDABOUTS-A USERS' GUIDE

With the completion of the BL-94 (Main St.) construction project from Paw Paw Ave. to Riverview Dr., two new roundabouts and striped bicycle lanes have come to downtown Benton Harbor. A roundabout is a circular intersection at which all traffic travels counter-clockwise, always to the right around a center island. Roundabouts are useful for several reasons, roundabouts:

- Keep traffic moving; and this decreases emissions and improves fuel economy
- Increase safety because there is no stopping in a roundabout, no left turns across opposing traffic lanes, and all vehicles must maintain similar speeds
- Force vehicles to slow to a safe speed for the intersection

How do I drive in a roundabout?

Roundabouts can be tricky to navigate when you have never encountered one. These simple tips below can ensure that the

roundabouts are used properly and safely by all multi-modal users in our community.

1. Before entering the roundabout, slow to the listed speed, in Benton Harbor the speed is 15 mph.

- 2. Vehicles entering from each leg of the intersection must yield to the traffic already in the roundabout.
- 3. When an appropriate gap in traffic appears, enter the roundabout and merge with the flow of the other vehicles.
- 4. Stay to the right of the center island.
- 5. Yield to all pedestrians crossing the roundabout.
- 6. Never stop in a roundabout for emergency vehicles. Exit the roundabout before pulling over to the side of the road.
- 7. Indicate your exit by using your turn signal.

The public is encouraged to attend the meeting and offer comments on the projects. Comments are also welcome after the meeting on the projects themselves and their prioritization.

What is (CMAQ) funding?

This program provides a flexible funding source for state and local governments to fund transportation projects and programs to help meet the requirements of the Clean Air Act (CAA) and its amendments. CMAQ funding supports transportation projects that reduce mobile source emissions in areas designated by the U.S. Environmental Protection Agency (EPA) as "nonattainment" or "maintenance" of national ambient air quality standards.

New Fixed Bus Routes In Twin Cities

Twin Cities Area Transit Authority (TCATA) began operations for two new fix routes for the residents of Benton Harbor on December 14th, The Red route goes from downtown 2009. Benton Harbor to St. Joseph, St. Joseph Charter Twp, and Stevensville. The hours of operation for this route are Monday-Friday (M-F) 6 am-10 pm and Saturdays 8 am-10 pm. The Green Route makes a loop through Benton Harbor and Benton Township. The hours of operation for this route are M-F 8 am-5 pm. The Red and Green routes run every hour and cost \$1.00 each way, even if a transfer to another bus route is necessary. The Blue route, the Benton Charter Township/retail loop, started extended hours on November 1, 2009 and runs M-F 6 am-10 pm and Saturdays 8 am-10 pm.

Van Buren County Passes Phosphorus Ban

Background

The Paw Paw River Watershed Management Plan authored by the SWMPC recommended the passing of a countywide phosphorus ban. The SWMPC thanks the County Board of Commissioners for taking this important step to protect inland lakes, rivers, streams, wetlands, and Lake Michigan. These water resources provide many benefits to the general health and welfare of the public.

Van Buren County has recently joined the Lake Michigan shore counties of Allegan, Muskegon and Ottawa, in adopting an ordinance that requires the use of phosphorous free fertilizers on all residential, commercial, and golf course lawns beginning January 1, 2010. The ordinance exempts agriculture, gardens, flowers, trees, shrubs, new lawns, and lawns with soil tests indicating phosphorous is required. This new ordinance will be enforced by the County Drain Commissioner's Office.

Why ban phosphorus?

Plants need phosphorous to grow, however, most soil types have enough naturally occurring phosphorous to sustain healthy lawn growth. When excess phosphorus is applied it can enter nearby waterways causing pollution of our water resources. One pound of phosphorous can support the growth of 750 pounds of algae!

What do those numbers mean?

The Two Rivers Coalition, Van Buren Conservation District, and the County Drain Commissioner are partnering to educate residents about the phosphorus ban and proper lawn care. Their new campaign is called "Zero In The Middle." When purchasing fertilizer, the numbers on a bag represent the three main nutrients: Nitrogen (N), Phosphorous (P), and Potassium (K). When you purchase fertilizer look for a "0" in the middle of the ingredients.
