1. Call to Order / Introductions and Pledge of Allegiance

Serita Mason, policy vice chair, called the meeting to order at 1:30 and led the group in introductions and the pledge of allegiance.

2. Changes to the Agenda

Brandon Kovnat asked to add an amendment for the City of Niles to the Agenda.

3. Public Comment

None.

4. Approve Minutes from the January 23, 2018 Meeting

Motion to approve the January 23, 2018 Joint Technical Advisory and policy Committee meeting minutes by Dawn Bolock, second by Roseann Marchetti. **Motion approved**.

5. Staff Report

2045 Long Range Plan Guiding Principles: Kim Gallagher gave an overview of the draft version of the guiding principles. She explained that instead of goals and objectives the LRP would be divided into guiding principles and performance measures. Some of the Performance measure were dictated by FHWA or FTA while some will be set by NATS based on staff recommendations. Safety was given as an example of a guiding principle section. Examples of the strategies and performance measures were shown.

Georgia Boggs asked about safety and if the Long range Plan would include safety improvements on 11^{th} street. She also expressed concern about safety at Gumwood and US-12.

Brandon Kovnat replied that the Long Range Plan would lay out general strategies to meet safety performance targets. He said that one such strategy would be to have MDOT consider safety issues when they were doing projects. Brandon then said that 11th street, which is M-51, is a MDOT road that will have a scoping project coming up and that the NATS committee would stay engaged to ensure safety improvements were explored. Brian Sanada said that there would be public meetings and he would announce them at the NATS meetings. Brandon followed up that US-12 was getting a path near Edwardsburg and Gumwood was getting a path near Redfield Rd. Extensions of both paths could be potential projects in the future.

2045 Long Range Plan Transit Overview: Kim Gallagher presented a working draft of the transit section. She presented ridership, revenue, and cost per passenger trends, for the Niles Dial-A-Ride and the Buchanan Dial-A-Ride.

Georgia Boggs asked about transit to connect people in Niles to Jobs in Cass County. Kim Gallagher said that rural trips like these would be very expensive because of low ridership and return trips with empty vehicles. There was a company called Liberty Transportation which was branded as the rural "uber' but it had gone out of business. Evan Smith said that Berrien Bus relied on contracts to fill these type of trips such as with the mental health court that pays an hourly rate. Bu he said it was still hard with a limited budget.

6. Community Land Use and Zoning Member Updates

None

7. Public Transit

Berrien Countywide Service Plan: Evan Smith said that the technical committee was waiting for a memo from the consultant.

Niles Dial A Ride: Kelly Getman-Dissette said that Niles Dial-A-Ride's facility had flooded. They are operating out of the law enforcement building. It could take months to reopen, but they are insured.

Buchanan Dial-A-Ride: Kim said that she would be presenting an amendment for the 2019 budget later in the meeting

8. Project Status Updates:

City of Niles: 17th Street is expected to be let on March 2. They will be requesting an increased project cost.

City of Buchanan: no update for the River Road Signal Projects.

Cass County Road Commission: No Update for Mason Street.

MDOT: US-12 resurface would have its construction moved to July.

US-31 would have the design work begin in June.

9. Old Business

Transportation Improvement Program Amendment Policy: Brandon Kovnat said that there were requests to update the TIP amendment policy so that projects that didn't require federally reviewed amendments could be made administratively without an MPO committee vote. There was a consensus that the NATS amendment policy should match the state & federal amendment policy. Brandon said that he would send a revised policy to committee members and a vote would be help next meeting.

10. New Business:

TIP Amendment for Buchanan Dial A Ride: Kim O'Haver presented the FY 2019 budget for Buchanan Dial-A-Ride (See attached amendment request letter). She said that there were no capital requests. Further, she said that local sources including fares and the city of Buchanan provide 40% of the operating budget.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve the FY 2019 budget requests from Buchanan Dial-A-Ride made by Kelly Getman-Dissette, Second by Jim Sturdevant. **Motion Approved.**

Motion for the Policy Committee to approve the FY 2019 budget requests from Buchanan Dial-A-Ride made by Roseann Marchetti, Second by Robert Ziliak. **Motion Approved.**

TIP Amendments for MDOT: MDOT presents a list of 15 job phases to add to the TIP (see attached amendment request letter). A number of these amendments were different phases of the same project or different phases of projects that were already in the TIP.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve all 15 of MDOT's job phases as presented made by Jim Sturdevant, second by Kelly Getman-Dissette. **Motion Approved**.

Motion for the Policy committee to approve all 15 of MDOT's job phases as presented made by Kelly Getman-Dissette, second by Roseann Marchetti. **Motion Approved**.

TIP amendment for city of Niles: The amendment request for the city of Niles was presented to the Committees (see attached amendment request letter). The city requested to increase the budget for 17th Street to pay for unforeseen ADA ramps and traffic loops. They propose to change their local contribution from 35,330 to \$91,000 which an additional \$55,670. The federal amount will remain the same. Brandon Kovnat explained that the requirements for n amendment were based on a 25% change in total cost, not just federal funds. The 17th street project had increased by 28% thus, an amendment was required.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve the City of Niles request to increase the local contribution for 17th street as presented, made by Jim Sturdevant, second by Kelly Getman-Dissette. **Motion Approved**.

Motion for the Policy committee to approve the City of Niles request to increase the local contribution for 17th street as presented, made by Robert Ziliak, second by Jan Personette. **Motion Approved**.

New Funds: Brandon Kovnat explained that the federal funding NATS would receive in FY 2018 is higher than the estimated amount in the TIP. There is \$44,123 federal STBG funds that are unprogramed.

Brandon Kovnat explained that this amount was too little to recommend a completely new project. Also due to time constraints, a new project would be difficult to be designed in time. Staff recommends using the funds in one of the currently programed projects in FY 2018. Brandon explained that there were three road projects. In addition, the funds could be flexed for use by Niles Dial-A-Ride. Staff will come up with scenarios, options, and an application. A vote on how to apply the funds would occur at the next meeting.

Long Range Plan Extension: Kim Gallagher said that NATs was going to request an extension on the Long Range Plan (LRP). Jon Roberts said that his was because they were waiting for MACOG to identify capacity projects to run in the Travel demand Model. NATS would need to reaffirm the current 2040 LRP before May. If they did this then they would not be required to amend the 2040 LRP to add in performance targets.

11. State and Federal Updates

Jim Sturdevant said that MDOT and SWMPC had held the Unified Work Program kick off meeting.

12. Privilege of the Floor:

Serita Mason wished to thank everyone that helped Niles with the flooding.

13. Adjournment

Meeting was adjourned at 3:30 PM. Next Meeting is scheduled for Tuesday March 27, 2018.

Purpose

This document provides guidance on the procedure to change projects in the Transportation Improvement Program (TIP). This includes how to determine if the process requires a federal amendment or if an administrative modification is sufficient.

Definitions (from CFR 450.104):

Federal Amendment, also referred to as an amendment, is any change to the TIP which requires Federal Highway Administration (FHWA) or Federal Transit Administration (FTA) approval. The amendment process requires public notice to allow for public review and comment in accordance with the SWMPC public participation plan. An amendment requires approvals from the MPO policy committee, MDOT, FHWA, and FTA. An amendment only applies to federally funded projects or projects that require air quality conformity (non-exempt). See Table on page 3.

Administrative Modification, also referred to as a modification, is any change to the TIP, which does not require federal approval. A modification does not require MPO committee approval or public notice. See Table on page 3.

Job Phase is any line in the TIP. A single project can be divided into multiple phases such as preliminary engineering (PE), right of way acquisition (ROW), or Construction (CON). Each phase must be listed in the TIP separately.

Illustrative List is a list of projects, which are not committed for funding in the TIP but have been added in case additional funding is available or another project in the TIP is removed. Changes to projects that are included only for illustrative purposes do not require an amendment. A project must still go through the federal amendment process to be moved from the illustrative list to the constrained project list.

Air Quality Conformity, also referred to as Conformity, is a requirement under the Clean Air Act (42 U.S.C. 7506(c) that federal funding and approval are given to transportation plans, programs and projects that are consistent with the air quality goals. The goal of transportation conformity is to ensure that a project will not cause or worsen air quality violations. This only applies to areas deemed to be in nonattainment or maintence. Projects that change capacity on a road always require conformity determination. Typically, any project that does not change a road's capacity does not require conformity analysis and is referred to as exempt.

Both Administrative Modifications and Federal Amendments must follow:

- 1. The financial constraint requirements, which means "A demonstration of sufficient funds (Federal, State, local, and private) to implement proposed transportation system improvements, as well as to operate and maintain the entire system, through the comparison of revenues and costs."
- 2. The current Long Range Transportation Plan
- 3. **Title VI Nondiscrimination,** which means "Title VI of the Civil Rights Act of 1964 (42 U.S.C. 200d), related statutes and regulations provide that no person shall on the ground of race, color, national origin, gender, or disabilities be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal funds. The Heart of Title VI "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance."

Niles Buchanan Cass Area Transportation Study Transportation Improvement Program Amendment Policy

Amendment Process:

The following steps must be taken for all proposed changes to the Transportation Improvement Program:

 The requesting agency must submit a letter to SWMPC requesting an amendment to the Transportation Improvement Program (TIP). The Amendment letter must be sent at least 10 calendar days prior to the regularly scheduled MPO meeting to allow for public notice. Amendments cannot be accepted after the 10-day deadline.

The letter must contain the following:

- Agency's letterhead
- A date
- Information to identify the project: Project name, limits, fiscal year of award, and
 MDOT job number (NA for Transit).
- The proposed changes to the project along with the current values (e.g. for a cost change: increasing from x to y)
- A brief explanation why the amendment is being requested
- A signature from an authorized individual

Letters can be sent via email or mail (see the example letters on the following pages)

- 2. Staff will review the amendment according to the approved TIP Amendment Policy in order to determine if the change requires a federal amendment or can be made as an administrative modification. For administrative modifications, staff will submit the request to MDOT; an administrative modification does not require committee approval or FHWA & FTA review.
- 3. All amendment request letters will be included in the meeting packet for the regularly scheduled MPO committee meetings. The packets are sent to committee members five business days prior to the meeting, and posted on the SWMPC website.

The following Steps only apply to changes, which require a federal amendment:

- 4. The requesting agency is expected to present their amendment request to the committees at the meeting and answer any questions.
- 5. At the regularly scheduled MPO meeting, the Technical Advisory Committee will vote on whether they recommend that the policy committee approve the amendment. This will be followed by the Policy Committee voting on approval.
- 6. Once an amendment has been approved by the MPO, staff will follow MDOT's process to submit the amendment to MDOT for approval. Staff will copy the requesting agency on the submittal and keep them informed about the status of the amendment.
- 7. MDOT reviews the amendment request to ensure it complies with all applicable regulations. These include air quality conformity, environmental justice implications proper public notice, and fiscal constraint.
- 8. Once approved by MDOT, FHWA and FTA each review the amendment. When FHWA and FTA approve the amendment, they will send a signed copy of the transmittal forms to MDOT & SWMPC.
- 9. Staff will notify the requesting agency as soon as the amendment has been approved.
- 10. Whenever amendments are approved, a revised TIP project list will be uploaded to the SWMPC website. Staff will inform the committees of any amendment approvals and changes to the TIP, including any administrative modifications, at MPO committee meetings.

Note on Administrative Modifications: An administrative modification is a type of change to the TIP, which does not require MPO committee approval, nor does it go through the federal review process. The process for an administrative modification is the same from steps 1 through 4. Because there is no need for committee approval or federal review the amendments can be programed as soon as staff receives the amendment request letter. Staff will let the requesting agency as soon as the administrative modification has been made. Staff will let committee members know if any administrative modification have been made at regular MPO committee meetings.

Niles-Buchanan-Cass Area Transportation Study (NATS)

Transportation Improvement Program Administrative Modification & Amendment Policy

Approved October 27, 2015

Introduction

This document provides guidance that defines the types of revisions to Niles-Buchanan-Cass Area Transportation Study Transportation Improvement Program (TIP). It highlights the differences between minor revisions defined as *administrative modifications* and more significant revisions defined as *amendments*. The guidance outlines steps for modifying the TIP document when such changes occur as well as actions needed by the Southwest Michigan Planning Commission transportation staff, the NATS Policy Committee, , the Michigan Department of Transportation, the Federal Highway Administration, and the Federal Transit Administration.

Regardless of the type of change to the Transportation Improvement Program, all modifications must be consistent with:

- 1. **The financial constraint requirements**, which means "A demonstration of sufficient funds (Federal, State, local, and private) to implement proposed transportation system improvements, as well as to operate and maintain the entire system, through the comparison of revenues and costs"
- 2. The current Niles-Buchanan-Cass Area Transportation Study Metropolitan Transportation Plan http://www.swmpc.org/nats 2040.asp
- 3. **Title VI Nondiscrimination**, which means "Title VI of the Civil Rights Act of 1964 (42 U.S.C. 200d), related statutes and regulations provide that no person shall on the ground of race, color, national origin, gender, or disabilities be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal funds. The Heart of Title VI "No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance."
- 4. The Niles-Buchanan-Cass Area Transportation Study Public Participation Plan procedures for public involvement, which outlines the strategies that the MPO will use to gain public participation http://www.swmpc.org/participation.asp

In 2015, NATS began the use of General Program Accounts (GPAs) to group projects together in order to increase the efficiency of TIP amendment submittals and reduce the frequency of amendments. A separate policy governing the use of GPAs has been created. All GPAs are still subject to the provisions of this TIP amendment and administrative modification policy.

Discretion for Administrative Modifications and Amendments

The Niles-Buchanan-Cass Area Transportation Study Transportation staff reserves the right to determine what is considered an administrative modification or an amendment depending on the project details and the consideration of factors of an amendment from the Federal Highway Administration and the Federal Transit Administration.

Amendment and Administrative Modification Decision Table

Each column represents when an Amendment, MPO Administrative Modification, and Federal Review will be done in a variety of categories.

- Administrative Modification=MPO Staff can handle without review by MPO Policy Committee or Federal Review, will notify Committees of change.
- MPO Amendments=Review and recommendation by MPO Technical Advisory Committee followed by Approval of MPO Policy Committee.
- Federal Review=When actions require the review and approval by Federal Highway or Transit Administrations.

The following definitions related to Transportation Improvement Program revisions are found in 23 CFR 450.104.

Administrative Modifications - An administrative modification is a revision that does not require public review and comment, redemonstration of fiscal constraint, or a conformity determination (in nonattainment and maintenance areas).

What needs to be done for Administrative Modifications?

- MPO staff makes changes in the appropriate fields of the e-File to reflect the new information. Note an administrative modification is made in the comment field or in the field where the error occurred;
- > MPO concurrence, at the time of the next TIP amendment according to agreed upon procedures; and
- > Submit all administrative modifications with the next TIP amendment request.

Amendment - means a revision to a TIP, or STIP. An amendment is a revision that requires a 7-day public comment review prior to the MPO meeting that the amendment will be discussed and notification to the public regarding a change to the TIP. It also requires recommendation from the Technical Advisory Committee and approval by the MPO Policy Committee. The amendment will require a redemonstration of fiscal constraint, or conformity determination (for TIPs involving "non-exempt" projects in nonattainment and maintenance areas).

What needs to be done for Amendments?

- > Take the proposed amendments, including air quality analysis if needed, out for public review per the NATS Public Participation Plan;
- Make changes to the e-File once the public comment period is complete;
- > MPO Policy Committee approval of proposed amendments, and determination of conformity if needed;
- Forward e-File, (updated project listing pages, updated financial constraint tables, and documentation of committee action, and documentation of public participation) to MDOT of the new TIP that includes the changes; and
- > MDOT forwards amendment packet to FHWA or FTA for their approval.
