B. Marquette Greenway Extension Efforts

- Collaboration with Northwestern Indiana Regional Planning Committee (NIRPC)
 - o Our sister regional planning organization for Porter, Gary, etc
- Major collaborative effort with public/private entities in New Buffalo City, Township and beyond
- Genuine opportunity to link the Marquette Greenway to Bike Route 35 (thus, a non-motorized path from Chicago to Traverse City)

C. Corridors for Development EDA Application

- Potential planning project to analyze the industry with the greatest potential for the region
- Then evaluate the criteria most necessary and attractive for those industries
- Map the geographic corridors where there is the greatest intersection of necessary resources
- Generate a product that is effective for the attraction of those prime corridors
