Kim Gallagher reported on the Pre-UWP meeting between SMWPC staff and MDOT on March 8. The FY 2018 Unified Work Program (UWP) will be presented to the TwinCATS committees at the May meeting and approved by the SWMPC board and then submitted to MDOT by June 1st.

Brandon Kovnat gave a presentation on Traffic Safety in the TwinCATS Planning area. [the power point of the presentation and safety report are posted on SWMPC's website as a handout to the March TwinCATS meeting

6. Land Use and Zoning Updates

Dick Stauffer said that sewer work for the Maiden Lane Condo project had begun Jonathan Fisk reported that St. Joseph Township has a draft revised master plan. The plan is available on the Township's website and there is a hearing on it scheduled for May 9th.

7. Public Transit Updates

Kim Gallagher gave an update on the Countywide Service Plan. She said there would be 3 stakeholder meetings from April 11-13. One in the Benton-Harbor area, one in the Niles area, and one for the rural area near Berrien Springs. Public meetings will occur in May and will also be located in the same areas.

By using the additional funds in 2017, Benton Harbor will only need to have an AC of \$99,000. TwinCATS will then have \$87,00 extra in 2019. Before FY 2019 begins, TwinCATS committees will review projects in the illustrative list and choose a project to use the funds.
