### 5. Staff Report

Brandon Kovnat gave a review about the Long Range Plan. In the upcoming meetings, a technical memo will be presented which contains data about the TwinCATS area that will be used in the Long Range Plan. Non-motorized transportation will be the topic of the tech memo presented at the October meeting.

# 6. Community Land Use and Zoning Member Updates

Dick Stauffer said that out lot for t Meijer were up for sale. There was an application by AutoZone. This led to a discussion about safety on Red Arrow around Meijer due to the placement of cones. There was concern that the cones were causing dangerous merging in the area where the lane is closed.

#### 7. Public Transit

**County-Wide Transit Project**: Kim Gallagher said that the CEO of Nelson Nygaard is now leading the study. She hopes this will rebuild enthusiasm. Kim also said that University of Michigan was conducting a study on mobility, water, and runoff. Researchers are exploring how technology can be used to solve area problems.

# 8. Airport Updates – Vince Des Jardins

Papi lights are being installed. These lights guide planes on approach. It is being 95% fed/state funded and 5% local. Kim asked about how the airport was used. Vince said that they do not track the cargo of each plane. However, he said that UPS has regular flights and that manufactures regularly charter planes to get parts to other factories. The nuclear plant also often needs just in time deliveries because it is cheaper to charter a flight than to shut down the plant while parts are delivered by other means.

## 9. Agency Project Status

## 2017 Projects:

Berrien County Road Commission: All FY 2017 projects have been completed

Village of Stevensville: The Red Arrow & John Beers Road Intersection project is completed.

There was a complement on the quality of the intersection.

**City of Benton Harbor**: Colfax South was let. Construction will occur any day.

**MDOT**: There was an Administrative amendment to move the I-94 WB overlay PE phase (JN 128907) from 2018 to 2017.

#### 2018 Projects:

**Berrien County Road Commission:** Brian Berndt explained that Nickerson Avenue would be a Mill and Fill replacing 2 inches. The plans have been approved. Shawnee Rd is an overlay with a wide shoulder added. The plan for this will be completed in about 2 weeks.

**St. Joseph**: Tom MacDonald discussed the Wallace Avenue project. Three options were presented to St. Joseph residents at a public meeting. The final plan chosen will narrow lanes on Wallace Avenue and add a 10ft path. This will eliminate street parking from Lakeshore Dr. to Stadium Dr. Street parking will be available at Dickerson Park. An improved crossing of Wallace will be added at Stadium Rd.

A comment was brought up by Alex Little about the desperate need to fix M-139 from Napier to Nickerson. He explained that the road was in such a poor condition that it was causing maintenance issue with buses. Jason Latham explained that the road needs Restore and Rehabilitation. Jason explained that 90% of the R&R funds are used on the interstate.

The cost for repair on M-139 could be up to \$25 million. He explained that smaller fixes and patching would not be the best use of funds. They might do some patch with leftover maintenance funding. He explained that M-139 is a major problem, which will require larger funding sources.

Katie also asked if there were any proposed projects or ideas that they wanted to test with the model. The future year data will be voted on at the November meeting.
