Project Connection

Last October, the Van Buren County Continuum of Care and the Southwest Michigan Planning Commission partnered to host *Project Connection!* the County's first Project Homeless Connect event. Over 125 adults received assistance for themselves and a reported 189 minor children. The event was successful due to the dedication and support of the social service agencies working with Van Buren County and a large number of wonderful volunteers. A second event is scheduled for April 17, 2008.

Although there are not a large number of homeless people on county streets, there are many residents who are precariously housed, doubled-up, at risk of eviction, or dealing with one or more of a wide variety of problems. Transportation around Van Buren County's rural landscape is an additional challenge to those striving for self-sufficiency. To address this broad scope of issues, the one-stop-shop day is called Project Connection! - a way to help people "connect the dots" of transportation, agency contacts, appointments, evaluations of eligibility, legal assistance, and many other services that can often seem overwhelming.

The April 17 event will be held at the Van Buren ISD Technology Center in Lawrence from 1:00 p.m. to 6:00 p.m. In addition to assistance provided by the social services agencies, the students at the Tech Center will provide haircuts, blood pressure readings, and help in several other ways. Child care and bilingual (Spanish) translation services will be available and there will be free hot food from 1:30 p.m. until 5:00 p.m. If you would like more information or are interested in volunteering, please call Shelley Klug at 269-925-1137 x13.

In addition, US Fish and Wildlife, Partnership for Fish and Wildlife Habitat Program; Michigan Department of Agriculture, Inter-county Drain Board; National Fish and Wildlife Foundation; St Deny's Foundation; Pheasants Forever, Cass County Chapter; and the Dowagiac Conservation Club were also honored for their participation.

The objective of the project was to reconnect a portion of the Dowagiac River with its original floodplain creating a channel that would restore the functions of a natural stream. Goals included involving stakeholders such as fishermen, canoe enthusiasts, and businesses catering to those recreational activities to once again take ownership of the River. John Egelhaaf explained that the relationships that were built over the years and collaboration between units of government were "sustained through hard work and dogged dedication to the underlying virtue of the project." Great financial and technical problems were overcome through the efforts of all parties concerned.

Bill Westrate, responding on behalf of the entire group, commended the hard work of all the partners and thanked the Commission for the recognition of their efforts.

Scenic Byways Grant Awarded to US 12 Heritage Trail to Create a Visitor Experience Strategy



The 212 miles of the US 12 Heritage Trail in Michigan is home to exceptional historic, cultural, and recreational features. Building on the foundation laid by the US 12 Heritage Trail Corridor Management Plan (CMP), the US 12 Heritage Trail Council wanted to integrate the hundreds of individual destinations into a single destination with hundreds of resources working together to tell the story and capture the imagination of travelers.

The US 12 Heritage Trail Council, which includes representatives of local government, and stakeholders throughout the corridor, realized that connecting with a place, enjoying quality infrastructure, and personalized service were vital to the success of any visit, but it is interpretation and engagement that make the difference between a pleasant break and an *unforgettable experience* along the US 12 Heritage Trail.

Through a \$228,000 grant from the Scenic Byways program, a Visitor Experience Strategy (VES) will be created and implemented. The US 12 Heritage Trail will now move forward to be the host of *unforgettable* experiences that reflect its strengths and complement the aspirations of the US 12 Heritage Trail aspirations. For example a VES could include interrelated railroad experiences along the trail that would include visits to railroad museums, taking a ride on the rails, and meeting some locals along the way with stories to tell.

Community enthusiasm, involvement, local knowledge, and passion for place are integral to the creation and implementation of this VES. Residents are the keepers of the stories and engagement with locals is fundamental to the unforgettable experience. Unfortunately, residents sometimes do not recognize what aspects of the natural and cultural heritage will be of interest to others. The VES will offer communities the opportunity to discover their own heritage and a strategy to communicate it to visitors with passion.
