1. Call to Order / Introductions

Berndt called the meeting to order at 2:10 PM and led the group in introductions.

2. Overview of Small Urban Program

Berndt said that everyone in attendance had been at a Small Urban funding meeting in the past, and there had been no changes to the funding or structure of the program in Michigan. Each Small Urban Area is still eligible to receive \$375,000 in federal funds every two years to use on transportation projects.

3. Approve Minutes of the April 21, 2016 Small Urban Meeting

A motion by Hildebrand with support by Dustin to approve the minutes of the April 21, 2016 meeting as presented. **Motion Passed.**

4. Review 2019 Project and Prioritize Projects 2020 and Beyond.

Hildebrand inquired about the switch in funding years from even to odd. Berndt explained that MDOT occasionally changes funding years depending on the funding levels and need. Berndt noted that Snow Road is scheduled for a reconstruction between US 31 to 1500 ft. west of Red Bud Trail in 2019 utilizing the full \$375,000.

Three applications were submitted for future funding by the Berrien Road Department. Berndt suggested the following prioritization:

- 1. Red Bud Trail from Shawnee Road to M-139
- 2. Snow Road from Garr Rd to 1500 Ft West of Red Bud
- 3. Red Bud Trail from Grange Road to south Oronoko Twp. line.

A motion by Dustin supported by Hildebrand to approve Berndt's suggested prioritization of projects. **Motion passed.**
