# 1. Call to Order / Introductions

Technical Advisory Committee Chair Brian Berndt called the meeting to order at 9:30 AM and led the group in introductions.

# 2. Changes to the Agenda

Brian Berndt said that the resolutions in support of passenger rail service and the New Buffalo rail connection should be added to the agenda as New Business.

**Motion** for the Technical Advisory and Policy Committees to approve the agenda with the two resolutions added to new business. Made by Sue Wyman, Second by Chris cook. **Motion approved.** 

#### 3. Public Comment

None.

# 4. Approve Minutes from November 19,2018

Eric Lester was not recorded in the attendance and he should be recorded as absent. The acronym STBG should be included after Surface Transportation Block Grant.

**Motion** to approve the minutes from the November 19, 2018 combined Technical Advisory and Policy Committee meeting with corrections. Made by Chris Cook, second by Juan Ganum. **Motion approved.** 

# 5. Staff Report

**2020-2023 Transportation Improvement Program:** Kim Gallagher discussed the timeline for the development of the 2020-2023 Transportation Improvement Program (TIP). She reminded the committees that the project review/selection subcommittee was meeting after the TwinCATS meeting. The TAC and Policy Committees will officially select projects at the January 14, 2019 meeting.

**CMAQ:** Kim announced the upcoming Berrien County CMAQ meeting on January 16, 2019 at 2:30 pm held at the SWMPC office. She explained that the selection process was being updated from the last call with a CMAQ committee, approved by the SWMPC board, selecting the projects.

**US-31 Extension**: Kim Gallagher announced that MDOT had received a BUILD grant for the US-31 extension.

Amy Lipset said that the project was to build approximately 2.5 miles of US-31 from Napier to I-94, which will cost \$44 million. The grant is for \$20 million and MDOT is in the process of identifying the remaining \$24 million needed. The open to traffic date will be 20203. They need to obligate the grant by September 2020; this is a tight deadline since they need to reevaluate the environmental review and get final design completed.

Amy said that US-31 would need to be in the Long Range Plan. There were also be TIP amendments to add related project phases. One would be a utility phase being called the "Z phase" this is \$8 million to move a natural gas pipeline. With the associated reconstruction of the I-94 and I-94 BL /Main Street Interchange, the total cost for US-31 is \$115 million.

Kim said that Katie would be rerunning the travel demand model and MDOT would be rerunning air quality conformity analysis. The Long Range Plan (LRP) will still be approve today as planned but the changes for US-31 will be made as an amendment to the LRP in January.

**Westrain**: Ryan Fellows presented proposals for passenger rail in west Michigan on the *Pere Marquette* Amtrak line, which goes from Grand Rapids to Chicago through Bangor and St. Joseph. In 2004 a Midwest Regional Rail Plan was created that included rail from Kalamazoo to Grand Rapids, but would have closed the Bangor and St. Joseph stations. In 2017, a stakeholder group recommended a coast-to-coast line from Grand Rapid to Detroit. The group also recommended that the decisions be made by MDOT. Ryan asked the Committees to consider a resolution during New Business that says TwinCATS supports continued rail service on the *Pere Marquette* line (Bangor and St. Joseph).

Ryan also explained that the current *Pere Marquette* route goes through New Buffalo where it crosses the *Blue Water* and *Wolverine* Amtrak routes, which run on higher speed tracks. Currently there is no way for the *Pere Marquette* route to use this higher speed track. A rail connection is needed to allow the *Pere Marquette* to use the other rail line and to be able to make transferring between the routes easier. Ryan said that a feasibility and engineering study is the needed for this, and presented a resolution for TwinCATS to consider during New Business to support such a study.

## 11. New Business

Approval of the 2045 Long Range Transportation Plan: Kim Gallagher explained the process leading up to the approval of the Long Range Plan (LRP). She explained that FHWA had a deadline for approval today. The plan would need to be approved today but would then be amended at the next meeting to change US-31 to the plan.

Alex Little said that he was submitting a project to address the last mile issue in transit through a bike share. He asked if the plan would need to be updated to include this project.

Kim explained that the LRP mentions gaps in the transit system. Addressing this would be consistent with the Plan. Brandon added the LRP has some specific projects but also a lot of general projects categories which allows a lot of flexibility in programing funds in the future. Unless a project is adding capacity, the LRP will not need to be amended.

Kim explained that approval of the LRP would include approval of the Air Quality Conformity Analysis for Berrien County. She said the next step for the LRP approval will be a vote by the Southwest Michigan Planning Commission board at their meeting on December 18, 2018.

#### 1. Call to Order/Purpose/Introductions

Gallagher called the meeting to order at 11:04 AM. Gallagher reviewed the purpose of the meeting was to review projects submitted for the Transportation Improvement Program (TIP) to make a recommendation to the Technical Advisory Committee, which in-turn advises the Police Committee, who makes the decision. She also reviewed the definitions of some of the terminology that might get used, such as advanced construct (borrowing funds from future years) and conversions (taking of funds to use in a previous year).

Berndt noted the TIP required fiscal constraints – meaning that funds must be spent in the year given or they will be returned to the State of Michigan. Stauffer emphasized the importance of not losing funds. Gallagher noted that it has been many years since TwinCATS lost funds.

Cook started a discussion on the scoring methodology used on the submitted projects. He said he thought the scoring system was not perfect. For example, sometimes 3R projects were recorded as 4R projects. He said judgment needed to be applied on Complete Street points on exempt projects. More consideration is needed on crash reduction factors scoring. Also, which sort of planning document should count for points? He doesn't necessarily believe the scores are right. Zebell offered that next time a peer review session could be held with engineer committee members and SWMPC staff.

## 2. Public Comment

Heather Cole of Be Healthy Berrien presented the Sub-Committee with a letter stating the importance of non-motorized infrastructure and support for Complete Streets.

#### 3. Project Selection

Berndt reviewed with the Sub-Committee already approved projects. He noted that the Hickory Creek Bridge project in Lincoln Township had to be scaled down due to the wetland not being good for sidewalk construction and that the State would not give a permit for it. Paved shoulders would be used instead. He said \$100,000 would be Lincoln Township cost and \$270,000 would be Berrien County Road Department cost.

Sturdevant and Kovnat entered the meeting at 11:30 AM. A recap was given to catch up Kovnat and Sturdevant on the scoring methodology issues. Gallagher noted that the hope was to take opinion out of the process. Kovnat said that clarity was needed on answers stating an increase of asset life expectancy versus just stating life expectancy. Cook noted the difficulty of doing crash reduction factors.

Sub-Committee members reviewed the various projects. Berndt sought balance so that each jurisdiction could be awarded a project. Because the request for Langley Avenue is so large, funding needed to come from two years.

**Motion** for the Sub-Committee to recommend to the Technical Advisory Committee to recommend that the Policy Committee approval of the following TIP projects within the specified years.

2021: Langley Avenue \$650,000; Marquette Woods Road \$325,000 (\$50,000 advance construct from 2023)

2022: Red Arrow Highway south \$656,000; Empire Ave. \$339,000 (\$45,000 advance construct from 2023)

2023: Lake Street \$440,000; John Beers Road \$224,000; Napier Avenue \$256,000; \$50,000 Marquette Woods Road conversion to 2021; \$45,000 Empire Avenue conversion to 2022

The Illustrative List top priorities will be: 1. Washington Avenue; 2. Pipestone Street; 3. Langley Avenue; then remaining application projects per score order.

Motion by Cook, second by Zebell. Vote: 5 yes, 2 no – **Motion approved.** 

For the record, Little objected to Empire Avenue being pushed into 2022 rather than the requested 2021. He said his busses where taking damage from Empire Avenue, and that the work could not wait.

Although it is not possible to commit 2024 funds at this time, it is the intent of the Sub-Committee to have the top priority of the Illustrative List be funded in 2024.

Meeting was adjourned at 1:03 PM.
