# Niles-Buchanan-Cass Area Transportation Study Joint Technical Advisory Committee and Policy Committee Meeting Tuesday, March 28, 2023

### 1. Call to Order and Roll Call

Technical Advisory Committee chair, Joe Bellina, called the meeting to Order at 1:30 pm. Kim Gallagher took roll call.

## 2. Changes to the Agenda

None.

#### 3. Public Comment

None

## 4. Approve Minutes from the January 24, 2023 Meeting

**Motion** to approve the minutes from the January 24, 2023, Joint NATS Technical Advisory Committee and Policy Committee Meeting. Made by Joe Ray, and seconded by Sandra Seanor. **Motion approved.** 

#### 5. Staff Report

6. FY 2024 Unified Work Program (UWP): Gallagher explained that the Unified Work Program (UWP), layouts out the tasks staff will undertake for NATS in Fiscal Year 2024, along with the planning budget. SWMPC staff met with MDOT and federal partners on March 9<sup>th</sup> to review the current progress on the FY 2023 UWP and discuss the goals for the FY 2024 UWP. For FY 2024, SWMPC requested additional funding to hire a consultant to write an EV readiness plan. This plan would focus on local charging infrastructure needs, unlike the statewide plan which only identifies general locations statewide. The UWP will be voted on at the May NATS meeting.

Carbon Reduction Program (CRP) & Transportation Alternative Program (TAP): Gallagher reminded the attendees that the call for projects to use NATS CRP7 the NATS TAP funds was sent last June a 2023-2026. Staff received one request to use the CRP in 2024. The TAP funds are unique because they can carryover, for up to four years, if not used. Due to the small allocation of TAP funds, typically NATS has selected a single project that combines multiple years of funding. No applications for TP were submitted. Another call for projects for both the CRP and the TAP funds will be sent out within a month.

#### 7. Local Agency Updates

**Berrien County Road Department:** Stack said the Bertrand project was Let in March with the accepted bid 14% above the programmed estimate of \$592,952.

**City of Buchanan:** Murphy said the complete biddable package for the Front Street Signal and the Front Street Reconstruction would be submitted to MDOT by April 23<sup>rd</sup>.

Cass County Road Commission: Bellina said that they acquired the ROW for the Gumwood & Redfield roundabout. The project is set for letting, with construction to begin in July. Road Commission crews began tree clearing today (3/28/2023). To avoid, distributing the nests so the endangered Indian Bat, tree clearing must be completed by April 1<sup>st</sup>. Any work funded federally (i.e. NATS STBG funds) must be done by a private contractor, selected through the MDOT bid-letting process. Due to the time constraint, the tree clearing was done in-house, without using any of the federal funds.

Bellina said he was confident that the Gumwood Realignment project would be approved in FY 2023. He plans to submit the GI package in the next few weeks. The ROW has not been acquired yet.

## 8. Transit Updates

Miller said Niles Dial A Ride increased their starting wages to be competitive with hiring.

## 9. MDOT Updates

Smith did not have any updates beyond what was included in the meeting packet.

#### 10. MDOT Amendment Requests

See the meeting packet for amendment details. Smith highlighted that there was a new fund source called Vulnerable Road Users (VRU) which was being used for a PE phase for a crosswalk project. he said this is a very new program and he's still learning more about it.

Smith explained that MDOT had initially scheduled a much larger repair for US-31S. Due to high costs, this rehabilitation was pushed back past the 2023-2206 TIP period. To maintain the road until then, MDOT added in added the Concrete repairs in 2024. Construction may not occur until 2026.

There were several comments about the poor conditions on US-31. Members thanked MDOT for scheduling repairs but thought they needed to be done sooner. Smith explained that US-31 Northbound was scheduled for repair this year, and MDOT is prepared to move the US-31 Southbound project up if funding becomes available.

**Motion** for the Technical Advisory Committee to recommend that the Policy Committee approve the Amendments to the NATS 2023-2026 Transportation Improvement Program (TIP) as presented. Made by Jim Sturdevant and seconded by Joe Ray. **Motion approved.** 

**Motion** for the Policy Committee to approve the recommendation from the Technical Advisory Committee. Made by Sandra Seanor and seconded by Susan Flowers. **Motion approved.** 

#### 11. Road & Bridge Condition Performance Targets

Kovnat discussed the *NATS 2022 Pavement Condition report*. He explained that the report summarizes the PASER ratings within the NATS area, including the 10-year trends, and ratings by jurisdiction. He explained that the PASER ratings are used in project selection and in creating asset management plans.

Kovnat then presented the national pavement performance measures which FHWA requires all states to set targets for. These measures use Pavement Condition Metrics (PCM) which are a combination of the International Roughness Index (IRI), Cracking Percentage, and Rutting/Faulting. Kovnat briefly discussed how the PCM differs from PASER, and why the same road may be classified as poor under PASER but fair under the PCM. The Michigan Transportation Asset Management Council (TAMC) chose PASER as the statewide measure for Pavement condition. Therefore, the TAMC reports sent to the Michigan Legislature give a different view of pavement condition than the reports sent to FHWA.

Kovnat presented the MDOT statewide pavement condition targets for 203 & 2025. These targets are for the entire state and only apply to roads classified as interstate or Non-interstate National Highways (NHS). Within the NATS area, there are no interstates, and most of the NHS roads are maintained by MDOT.

Kovnat briefly explained how bridges are rated, and presented the statewide bridge condition from 2021 along with the 2yr & 4yr statewide bridge condition targets. He said that more details on bridge condition in the NATS area would be included in the next NATS Long Range Plan which will be approved in June.

**Motion** for the Technical Advisory Committee to recommend that the Policy Committee approve the 2022-2025 Statewide Pavement and Bridge Condition Targets as developed by MDOT and included in the meeting packet. Made by Jim Sturdevant and seconded by Susan Flowers. **Motion approved**.

**Motion** for the Policy Committee to approve the recommendation from the Technical Advisory Committee. Made by Bill Kasprzak, and seconded by Sandra Seanor. **Motion approved.** 

### 12. Privilege of the Floor or Public Comment

Joe Ray expressed his anger over the extreme bureaucracy required to get federal funding for even a simple "mill & fill" project. It often requires hiring a consultant and greatly increase the cost. Because local agencies can't use federal funds for design (PE), the agency ends up spending far more than the 20% match for construction. He also felt that due to the increased time for project approval, it will become impossible to capture additional federal funds that may become available. Another issue is that in FY 2024, MDOT would be the only agency on the November, December, and January lettings. Since the lowest bid must be accepted, this could mean by February, only the more expensive contractors will be bidding on projects.

Bellina discussed the Local Federal Fund Exchange (LFFE) program available for the Rural Task Force (RTF). This allows agencies to trade federal funds, with another agency for local funds. The exchange is typically about 0.8 local for federal. He asked if this could be used for Urban funds. Sturdevant replied that MDOT had a program where they will "purchase" federal funds for 0.9 in non-federal funds. Agencies must apply for this well before the beginning of the fiscal year their project s programmed for. The MDOT exchange, unlike the LFFE, cannot be used on a new project, if funds are announced after the start of the Fiscal year.

## 13. Adjournment

The meeting was adjourned at 2:35 pm. The next meeting is scheduled for Tuesday, April 25<sup>th</sup>, 2023 at 1:30 pm.

# **FY 2023 Funding Availability**

On May 11, 203 the Cass County Road Commission informed SWMPC Staff that due to delays in the right of way acquisition, the Gumwood Realignment Project cannot be obligated in 2023. This leaves the \$339,282 in FY 2023 NATS Funds unprogrammed.

On May 15, 2023, MDOT informed Staff that there was \$11,849 in HIP funds that NATS could use in FY 2023 (the HIP is used the same as STBG funds). Due to these recent announcements:

NATS has \$351,131 available which must be obligated in FY 2023. To utilize this funding, the NATS Technical Advisory Committee and Policy Committee are being asked to vote for one following Options:

## Option A: Add Funding to The City of Buchanan Front Street Project

In January 2022 the city of Buchanan requested to utilize as much federal funding as possible for the Front Street Reconstruction and to remain in consideration for funding in case the Gumwood Realignment could not be obligated in FY 2023.

## Option B: Move the Gumwood Project to 2024 and Move the City of Niles Wayne Street project to 2023

The Cass County Road Commission and the City of Niles proposed to move the Gumwood project to 2024 by swapping it with the City of Niles FY 2024 Wayne Street Project. Although not specifically requested, SWMPC staff added the \$11,849 of HIP funds to the proposal, in order for this option to fully utilize all available 2023 funds.

## Dear TAC and Policy members:

When funding was allocated to the north leg of the Gumwood/Redfield roundabout the Cass County Road Commission promised that if we felt that we might not meet obligation we would do what is necessary to keep these funds local. The design portion of the project will meet the necessary markers to achieve the goal, but due to delays the ROW acquisition may not.

We respectfully request that the 2023 project for the north leg of the roundabout be moved to 2024 and the City of Niles project on Wayne Street, JN 216092, be moved to 2023. We have spoken with Joe Ray and this exchange is acceptable to the City. This would allow the \$339,292 in 2023, currently allocated to the north leg of the roundabout, to be used locally on an approved project. We additionally request that the current amount of \$252,514 in 2024, currently allocated to the Wayne Street project be allocated to the roundabout project and then be supplemented with the balance of \$82,000 in 2024 unallocated STBG funds, bringing the total federal funds for the roundabout north extension to \$334,514. The reduction in federal funds of \$4,778 on the roundabout project will require an increase in local funds of the same amount from the Cass County Road Commission.

We still expect the north leg of the roundabout will be constructed in 2024.

# Congestion Mitigation & Air Quality Improvement Performance Targets for the 2022-2025

The Congestion Mitigation and Air Quality(CMAQ) Program has three performance areas. The *Total Emission Reduction Performance Measure* (23 CFR 490 Subpart H), requires MPOs, which receive CMAQ funding due to being within a non-attainment area, to set 2-year and 4-year targets for the reduction of criteria emissions.

The Peak Hour Excessive Delay (PHED) and Percent Non Single Occupancy Vehicle (SOV) Travel Targets (23 CFR 490 Subpart G), only apply to urban areas with a population of above 200,000 and up. The PHED is a measure of delay on the National Highway system during the most congested (peak) hour of the day. The Percent of non-SOV travel is the percent of the population in the urban area who commute to work by any means other than driving alone in a vehicle; this can include carpooling, transit, walking, or biking to work.

Statewide targets for the *Total Emission Reduction Performance Measure* were developed by MDOT through coordination with each MPO in Michigan that is within a non-attainment area. The PHED and non-SOV targets are set by urban area, and were developed in coordination between INDOT, MDOT, MACOG (South Bend MPO), and SWMPC.
