Minutes

NILES BUCHANAN CASS AREA TRANSPORTATION STUDY TECHNICAL ADVISORY COMMITEE and POLICY COMMITTEE MEETING Tuesday, October 24, 2023 – 1:30 pm Niles District Library, Niles MI

<u>Call to Order and Roll Call</u> Joe Bellina, Technical Advisory Committee chair, called the meeting to order at 1:37 p.m. Kim Gallagher took roll call.

- 2. <u>Changes to the Agenda</u> None.
- 3. <u>Public Comment</u> None.
- Approve Minutes from the September 23, 2023, Meeting Motion to approve the minutes for the September 23, 2023 Joint NATS Technical Advisory Committee and Policy Committee Meeting. Made by Bill Kasprzak and seconded by Kevin Stack. Motion approved.

5. Staff Report

2020 Urban Boundaries: Gallagher informed the committees that the production of the proposed ACUB maps for the Michigan portion of the South Bend Urban Area and the Buchanan Urban Area was delayed. She added that MDOT has ensured SWMPC they would be available for review in early November for approval at the NATS November meeting.

6. Local Agency Updates

NATS Funding Reduction: Gallagher presented the NATS Project Review Subcommittee recommendations for addressing NATS's decrease in federal funding. This reduction is due to calculating the allocation based on the 2020 Census population, and a statewide penalty in 2024 and 2025 which transfers 2.5% of the State's STBG funding to safety programs. The subcommittee recommendation can be found on page 5 and 6 of the meeting packet.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve the Subcommittee's proposed amendments to the NATS 2023-2026 Transportation Improvement Program. Made by Joe Ray and seconded by Kevin Stack. The motion passed unanimously.

Motion for the Policy Committee to approve the recommendations from the Technical Advisory Committee. Made by Bill Kasprzak and seconded by Butch Payton. The motion passed unanimously.

City of Buchanan Use of 2024 Carbon Reduction Funding Allocation: The City of Buchanan provided an updated cost estimate for the McCoy Creek Trail Extension and requested to add the full 2024 Carbon Reduction Program (CRP) allocation of \$63,000 to the project.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve Buchanan's proposed amendments NATS 2023-2026 Transportation Improvement Program. Made by Joe Ray and seconded by Kevin Stack. The motion passed unanimously. **Motion** for the Policy Committee to approve the recommendations from the Technical Advisory Committee. Made by Jim Sturdevant and seconded by Bill Kasprzak. The motion carried unanimously.

7. Transit Updates

Pepper Miller requested to add \$17,000 in 5339 funding to a 2024 bus purchase project because of increased costs. She also requested the use of an additional \$40,000 in 5307 funding to cover increased maintenance costs in 2024. Pepper added that delivery time for transit vehicles has increased dramatically and therefore they are having to make repairs to vehicles that would normally have been replaced.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve Niles Dial A Rides's amendments NATS 2023-2026 Transportation Improvement Program. Made by Kevin Stack and seconded by Butch Payton. The motion passed unanimously.

Motion for the Policy Committee to approve the recommendations from the Technical Advisory Committee. Made by Jim Sturdevant and seconded by Lynn Ferris. The motion carried unanimously.

8. MDOT Project Updates and Amendment Requests

Gallagher presented the 2024 MDOT projects and asked Jon Smith to provide any updates or changes to what was presented. Gallagher noted that there was some discussion at the NATS Subcommittee meeting that the members would like more detailed updates from MDOT. Gallagher presented MDOT amendment request to increase the length of durable all-weather centerline and shoulder pavement markings. No cost changes.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve the MDOT project amendments NATS 2023-2026 Transportation Improvement Program. Made by Joe Ray and seconded by Susan Flowers. **Motion passed.**

Motion for the Policy Committee to approve the recommendations from the Technical Advisory Committee. Made by Bill Kasprzak and seconded by Susan Flowers. **Motion passed.**

9. Privilege of the Floor or Public Comment

Joe Ray and Kevin Stack raised a concern about the US-12/M-60 interchange road diet restriping and the possibility of some prior pavement markings that were still visible. They stated that it was causing confusion with drivers trying to navigate the new configuration. Jon Smith stated he would follow up with the appropriate project manager and get back to Kevin and Joe.

Susan Flowers asked about the timing for installation of a traffic signal at US-12 at Gumwood Road intersection. Jon Smith assured her that he would do some research and get back to her with that information along with the contacts for the construction engineer and project manager.




