## 1. Meeting Purpose and Structure

Mani opened the meeting at 1:05 PM. Mani stated that the purpose of the meeting was to make a preliminary selection of projects for the 2014-2017 TwinCATS Transportation Improvement Program (TIP), and that public comment could be made at any time in the meeting.

## 2. Additional Obligation Authority

Boyd called in via telephone and explained a letter from MDOT dated February 22, 2013. Due to leftover American Reinvestment and Recovery Act (ARRA) funding, as well as inability of local jurisdictions to meet local match, MDOT had a statewide balance of 54.3 million in STP obligation authority at the end of 2012.

Decisions were made in a work group as to how to divide this obligation authority, and ultimately a formula was created to distribute funds to various MPOs, small urban areas, and TMAs. As a result of this process, TwinCATS has an additional **\$453,972** in obligation authority for 2013. This authority would have to be obligated in 2013, or they would go back into a pool that all small MPOs would be able to access through a competitive process. To ensure that the obligation authority is spent on time, Boyd advised that projects would need to be submitted for grade inspection by May.

Berndt asked how small urban obligation authority would operate. Boyd suggested that meetings be scheduled on a local level to determine whether projects could be advanced.

Berndt suggested that the additional TwinCATS authority be spent on the Hollywood Road advanced construct (AC) project in 2013. This project is ready to be submitted for grade inspection, and has local match available. Also, by spending the authority now, it would free up money for other projects in 2014-2017.

## 3. Project selection process

Mani stated that SWMPC staff had prepared a list of locations of projects, including those by MDOT, in each TwinCATS jurisdiction over the past three years. Berndt noted that MDOT projects are not included in the local project selection process. Mani and Flowers acknowledged that, but stated that the purpose of the listing was to get subcommittee members to think about whether projects were being distributed fairly, and at the same time, whether they were going to areas where they would have the highest impact on regional population. Mani stated these geographical listings and long range plan goals were not meant to set rigid criteria for selection, because ultimately the TwinCATS Policy Committee could decide upon projects as they saw fit.

The table above reflects STP targets and initial requests for STP funds. Mani stated that we had an excess request in each year. Berndt stated that with the Hollywood Road project programmed for the additional obligation authority in 2013, the project would only need \$286,444 in 2014, leaving \$519,080 in additional funds for 2014.

Zebell asked whether construction savings of \$20,000 in 2012 on the Napier Avenue would be available for expenditure in 2013 and beyond. Woolcock said she would look into it. [After the meeting, Woolcock found that the \$20,000 in savings was rolled into the additional obligation authority awarded to TwinCATS for 2013].

Berndt and Zebell suggested that the first step to reducing the excess request might be to go through the spreadsheet and list out the traffic count and PASER ratings for each, which the group did. While the project requests were being described, Johnson asked a question of the possibility of bike lanes on Hilltop Road. Berndt said that bike lanes were in place from Cleveland to Lakeshore, and right of way considerations kept them from extending further.

Flowers asked what the critical ADT threshold was to convert a roadway from 4 to 3 lanes. Berndt said that this figure was around 12,000.

Cook suggested that the next step to reduce the excess requests was to have each community identify their top priority projects, and then shift them around to line up with funding levels. The top priorities were:

- City of Benton Harbor- Colfax Avenue resurfacing
- City of St. Joseph- Botham Avenue resurfacing
- Village of Shoreham- Brown School Road resurfacing
- St. Joseph Township- Hilltop Road
- Lincoln Charter Township- Marquette Woods Road

An issue arose with the Brown School Road and Marquette Woods Road projects both being scheduled for 2014, when funds would not be available. Olson stated that Brown School Road

was already in poor condition, and waiting would cause further deterioration. Smith and Austin stated that the Marquette Woods traffic had substantially increased since Meijer opened, and that safety was a major concern. Given different combinations of funding, Cook suggested that the Shoreham project be programmed for 2014.

Zebell argued that because the City of Bridgman received almost all of the ARRA funding, and that the cost of the project is so high, the Red Arrow Highway project for 2015 should be placed on the illustrative list rather than programmed.
