1. Call to Order and Roll Call

Kevin Stack Called the Meeting to Order at 1 PM and took roll Call.

Tami Naber announced that she was the alternate voting member representing Van Buren County Public transit.

2. Overview of the Meeting Purpose

Stack said that the purpose of the meeting was to vote on the project changes which were included in the meeting handouts (*see attached*)

3. Changes or Additions to the Agenda

None.

4. Approval of the Minutes of January 26, 2022, Region 4 RTF Meeting A typo in the minutes was brought up.

Motion to approve the minutes from the Region Four RTF meeting held on January 26, 2022 – with the typo corrected. Introduced by Kevin Stack with a second by Gerry Bundle. **Motion approved**.

5. Amendments to RTF projects

Agencies presented proposed project changes, noting that all amendments were approved at county RTF meetings except for a new project in Cass County.

Gerry Bundle requested a description change for the Cass County Transit Project from "security cameras" to "facility security upgrades," explaining that additional security features would be included.

Bellina explained that the Gumwood Realignment project, had an update to the funding amount. The Cass RTF held a meeting just before the Region meeting, approving funding for the 2023 project using \$532,244 in FY 2026 Cass RTF funds through an Advance Construct, with construction scheduled for FY 2024.

Gallagher announced that there was a public comment submitted about the Gumwood project. These comments were included in the Cass County RTF meeting packet but not in the Region 4 meeting packet. The gmwood Realignment requires building Gumwood through the property on the Northeast corner of Gumwood & Redfield. The comment, from lawyer Peter Agostino representing the property owner, opposed the realignment and supported an alternate option with two separate roundabouts.

Bellina addressed the public comment, referencing a 2014 study that determined a single 4-way roundabout at Gumwood & Redfield was the best option. He added that the Costs presented werefor construction only, and do not include property purchase.

Barry Anttila mentioned that the CR 388 request would lower the local match with no total cost change. The project, having recently had the GI meeting, plans to use \$1.2 million in ARRPA funds in 2024 to continue work from 29th street to the county line.

Motion to approve all project changes as presented. Introduced by Joe Bellina, and seconded by Gerry Bundle. **Motion approved**.

6. Notice by Cass County of Intention to Exchange FY 2023 Federal Aid Funds

Bellina notified the attendees that the Cass County Road Commission (Cass CRC) has an arrangement with Kent County to exchange all of Cass CRC's FY 2023 federal RTF funds (\$733,752) for local funding at an 80% exchange rate. He said that he could construct the projects for at least 80% cheaper himself than if he had to go through the LAP bidding process. The exchange process requires him to use the funds on the programmed projects, with rules on how any remaining funds can be used.

Don Mayle added that the Local Federal Fund Exchange (LFFE) was for county-to-county exchanges. Villages and cities can partner with a county to conduct the exchange. The LFFE is a negotiated exchange. This is different from the Federal Aid Buyout, where MDOT takes the federal funds and the exchange is a set of 90% local funds for federal funds. The state exchange also has requirements not included in the LFFE, such as having to follow prevailing wage laws (Davis-Bacon wages). Mayle also discussed a proposed Buyout program for State D funds. The process is under development.

7. Discussion / Changes to the All-Season Network

Maye clarified that an All-Season Road refers to a road designated by the RTF as All-Season and currently constructed to meet those standards. The All-Season Proposed category involves roads for which the RTF has approved the use of State D funds to upgrade them to All-Season standards.

Kovnat highlighted upcoming projects where State D funds were granted, but the roads aren't presently State D eligible. He encouraged agencies to consult the state's All-Season map to confirm that any road with State D funds is approved as All-Season by the RTF.

8. Discussion of Next Steps for Using Unprogrammed 2024-2026 Funds.

The unprogrammed balanced for FY 2024, 2025, and 2026 were presented. There was a discussion on when engineers estimates needed to be completed and when the RTF should meet again. Attendees agreed that the county RTF meetings should occur in March or April, and the Region RTF should meet again in April. Kovnat added that a county RTF meeting was not necessarily required if decisions were simple.

10. Adjournment

The meeting was adjourned at 1:55 pm.
