Purpose: for local government officials, engineers, and anyone with an interest in the environment to come together to discuss the following topics:


- What impact does the transportation system have on our water resources?


2. PASER (pavement system evaluation and rating) training

Announcements & Reminders

1. Funding available for pavement rating of local (non-federal aid eligible) roads

Funding is available in fiscal 2011 for all Act 51 (road-owning) agencies to rate the pavement condition of 100% of their local roads. The Southwest Michigan Planning Commission can also conduct the road rating on behalf of Act 51 agencies. The Michigan Transportation Asset Management Council must be notified as soon as possible with the number of miles that will be rated. 2. Investment Reporting deadline – April 1st, 2011

Under Act 51, the State of Michigan collects data from communities on their road and bridge projects from the previous year, using the Investment Reporting Tool (IRT). The report is due to the Michigan Transportation Asset Management Council by April 1, 2011. Log in to the investment reporting tool website at http://tamc.mcgi.state.mi.us/tamc/ to fill out your community's investment report. The instruction packet that was provided at the investment reporting tool training is also available on the website. Contact Dave Jennett at (517) 373-7910 / JennettD@michigan.gov with questions. 3. Traffic Counting services available

Every summer the Southwest Michigan Planning Commission conducts traffic counts on roads throughout Berrien, Cass, and Van Buren counties. Requests are taken first come, first serve.
