Niles Buchanan Cass Area Transportation Study JOINT TECHNICAL ADVISORY COMMITTEE AND POLICY COMMITTEE MEETING **Tuesday, June 27, 2023 – 1:30 PM** Niles District Library, Niles MI

1. Call to Order and Roll Call

Policy Committee chair, Richard Cooper, called the meeting to Order at 1:35 pm. Kim Gallagher took roll call. *(See packet page 4 for attendance)*

- 2. <u>Changes to the Agenda</u> None.
- 3. <u>Public Comment</u> None.

Approve Minutes from the June 27, 2023, Meeting Motion to approve the minutes from the May 23, 2023, Joint NATS Technical Advisory Committee and Policy Committee Meeting. Made by Butch Payton and seconded by Peper Miller. Motion approved.

5. Staff Report

Repeat Drunk-Driving Sentencing Minimums Federal-Aid Transfer Penalty Federal Law: Gallagher provided details on the impact of Michigan not meeting the federal sentencing minimums for repeat drunk driving. Going forward in 2024 the state will transfer 2.5% of STBG and NHPP to HSIP programs, usable for safety projects, police overtime, and other safety programs. 2.5% federal aid penalty of the two largest classes of federal road aid—Surface Transportation Block Grants (STBG) and National Highway Preservation Program (NHPP)—are transferred to the Highway Safety Improvement Program (HSIP). Gallagher noted that SWMPC staff will be reviewing the adjustments and communicating the revised funding estimates for 2024 which will include the 2.5 percent reduction and any 2020 census impacts on funding.

2020 Urban Boundaries: Gallagher updated the members on the 2020 Urban Area adjustment process and the various agencies involved in the future ACUB meetings. Gallagher provided a map illustrating the 2010 ACUB and the 2020 Census Urban Area. Gallagher noted one change with the City of Buchanan and portions of Buchanan township moving to a Small Urban Area.

6. Local Agency Updates

- **City of Buchanan:** Rich Murphy informed the committee that the 2023 Front Street project was obligated on June 16, 2023, and letting is scheduled for August.
- City of Niles: No update
- Cass County Road Commission: No update

7. MPO Consideration of Capped to Pro-rata for remainder of FY 2023

Gallagher provided an explanation with examples of Capped and Uncapped programs. She also reminded the committees about the maximum overage allowed is 24.9% at time of obligation and that any cost change of 25% or more (up or down) requires an amendment.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve changing the NATS funding system from Capped to Pro-Rata for the remainder of FY 2023 Made by Kevin Stack and seconded by Pepper Miller **Motion approved.**

Motion for the Policy Committee to approve the recommendation from the Technical Advisory Committee. Made by Sandra Seanor and seconded by Pepper Miller. **Motion approved.**

8. Transit Updates

Pepper Miller updated the committee that the new bus was on the road, and the driveway project has been completed. Ridership has been consistently increasing. Gallagher added that meetings will also be held with transit agencies to discuss the 2020 census impacts on public transit agencies going forward.

9. MDOT Project Updates

No other updates other than what was included in meeting packet.

Reliability Performance Targets

Gallagher introduced the Reliability Performance targets. She stressed that travel time reliability (TTR) measures how consistent travel time is from one point to another and from one day to the next and was not a measure of congestion but more about the variability of congestion over time. Gallagher also provided some examples to illustrate this.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approved the 2022-2025 Reliability Performance Targets as included in the meeting packet. Made by Roseann Marchetti and seconded by Bill Kasprzak. **Motion approved**.

Motion for the Policy Committee to approve the recommendation from the Technical Advisory Committee. Made by Serita Mason and seconded by Pepper Miller. **Motion approved.**

10. 2050 Long Range Transportation Plan

Gallagher explained the purpose of the Long-Range Transportation Plan along with some of the elements that were updated. Gallagher also noted the public comments that were received and documented in the appendix of the 2050 NATS Long Range Plan.

Motion for the Technical Advisory Committee to recommend that the Policy Committee approve the NATS FY 2050 NATS Long Range Transportation with any minor changes requested by MDOT. Made by Jim Sturdevant and seconded by Roseann Marchetti. **Motion Approved**

Motion for the Policy Committee to approve the recommendation from the Technical Advisory Committee. Made by Bill Kasprzak and seconded by Butch Payton. **Motion approved.**

11. Privilege of the Floor or Public Comment

Gallagher announced that there would be no July NATS meeting due to staff attending the annual Michigan Transportation Planning Conference.

12. Adjournment

The meeting was adjourned at 2:26 PM.
