### 1. Call to Order & Introductions

Meeting was called to order by Cooper at 1:06 p.m, also led the group in introductions.

### 2. Minutes

A motion by Cook with support by Bradfield to approve the TAC Committee Meeting minutes from February 25, 2014. **Motion passed.**

### 3. Public Comment

There were no public comments received.

### 4. Staff Report

#### ▪ MTPA Follow up

- Flowers reported that the TIGER 6 grants are now open. Flowers noted that she would send information and contact information to the group in the Talking Points message after the meeting. She noted that there were three applications from the area from the last call, one by City of New Buffalo, Pokagon Band, and Berrien County.
- Flowers also noted that the SWMPC pre-uwp meeting is coming up in April, transit agencies are encouraged to participate either on the phone or in person. Flowers explained that the UWP is the annual listing of what the MPO will work on in fiscal year 2015 which starts on October 1, 2014.
- Dewey noted that on March 14, 2014 rulemaking came out regarding the first of 3 groupings of performance measures, the first is safety. There are 4 major measures to focus on and that the MPO should read and comment during this process. The information can be found at [www.regulations.gov](http://www.regulations.gov) then enter FHWA-2013-0020. She also stated that in April planning regulations will be released, this is the interpretation of MAP-21, and this process does take some time to go through.

#### ▪ Local legislative letter regarding R3 funds

Flowers noted that some changes had been made from Joe Bellina and that no other comments had been received. Flowers discussed the point of the letter is to encourage the Michigan House and Senate representatives to discuss project selection with the MPO as there is a tremendous amount of knowledge and expertise around the table.

A motion by Gruchot with support by Smith to recommend to the Policy Committee to approve the letter and send it out to the State representatives. **Motion passed.**

#### ▪ Michiana Council of Governments (MACOG)

Mani noted that he has been attending MACOG meetings and learned a tremendous amount about US 31 and he asked our partners from MACOG to present information on that.

Turnwald reported on the three sections of US 31 that are taking place or have been built:

- Indianapolis section will be done in 2015 for a cost of \$342 million
- Kokomo section was completed in 2013 around Thanksgiving for \$55 million
- South Bend to Plymouth will be completed at the end of 2014 for a cost of \$225 million
- The US 31 coalition, is a group of citizens who are concerned about the gaps that the sections of US 31 are creating. They are asking about the gaps from Plymouth to Kokomo and Indiana DOT stated that there were no projects planned for completing this section

Joe Ray conducted the rest of the meeting.

## 6. Old Business

- **Rotating PASER Ratings**

Mani said that a request at the TwinCATS meeting in February that MPO jurisdictions go into a rotating system, so that a few jurisdictions could have their local (non-federal aid eligible) roads each year, and all NATS member jurisdictions would have their local roads rated every three years. Act 51 agencies are eligible to have their local roads rated every three years with reimbursement

from the state. Staff would review local roads to see who had had their roads rated recently. Mani said it was likely that all jurisdictions in NATS would be eligible right away, and that SWMPC staff were not always aware when local road ratings were done. Mani is planning to set this system up in Berrien County and wanted to find out if Cass County would also be interested.

- **TIP Plan Amendment**

The TIP amendment and administrative modifications policy was approved at the February 2014 meeting and in order to keep this document together the MPO staff are asking for the Committee to amend the 2014-2017 TIP document and in order to do so we need to put the amendment out for a 7 day public comment period.

A motion by O’Haver with support by Cook to put the 2014-2017 NATS TIP out for a 7 day public comment period to amend the plan to include the Administrative Modifications vs. Amendments Policy. **Motion passed.**

- **Walk and Roll**

- **Survey and Community stakeholder meetings**

Flowers noted that additional communities have agreed to input meetings and with a bit of press we have over 90 survey responses so far. Surveys continue to be available and committee members can ask for the surveys at any time.

## **7. New Business**

- **Land Use Updates**

Flowers stated that she and Mani attended the Kalamazoo MPO meeting last month and that they provide updates for land use in their MPO. Flowers noted that she thought it would be a good addition to the agenda each month and Mani added that it would allow communities to provide updates to the MPO even if they do not have construction projects happening in their community.

A motion by O'Haver with support by Gruchot to approve the TIP amendments as presented. **Motion passed.**

▪ **Legislative Updates-Federal and State**

○ **Federal**

Flowers asked if Dewey would present information about Inactive Projects and what that means for local agencies. Dewey noted that an inactive project is when a project is obligated and there have been no expenditures on the project in 12 months. MDOT has done a great job of closing out projects and ensuring that they take action on inactive projects. Michigan is not unique in this issue but MDOT is working on an internal policy to ensure that projects are tracked for inactivity. There was much discussion about what this means to local projects and how MPO staff should work with local agencies to see when billings have been made on projects. This was noted by MPO staff to include in project updates.

○ **State**

There was discussion about SB 608 which approved \$215 million dollars from the general fund for transportation projects, \$100 million will be distributed by formula for winter road maintenance, the remaining \$115 million will be for projects selected by the legislature and prioritized by the legislature leadership. Harden added that if projects are selected within the MPO boundaries that it is up to the MPO Committee to decide if the projects are regionally significant and should be included in the TIP. He cautioned that it can take up to 2 months to process TIP amendment changes and from the Senate Bill, all legislatively selected projects have to be obligated by July 1, 2014, and that could pose a challenge for local agencies.
